Blue Sky Electrolysis respects your privacy. This Privacy Policy explains how we collect, use, store, and protect information submitted through our website, booking system, intake forms, contact forms, payment tools, and related communication methods.

By using this website or submitting information to Blue Sky Electrolysis, you agree to the practices described in this Privacy Policy.

Information We Collect

Blue Sky Electrolysis may collect personal information that you provide directly, including:

- Name
- Email address
- Phone number
- Date of birth
- Booking information
- Payment and deposit information
- Intake form responses
- Treatment goals
- Skin and hair history
- Relevant health history, medications, allergies, or sensitivities
- Consent and acknowledgment forms

We may also collect basic technical information automatically through Wix and related website tools, such as IP address, browser type, device information, site activity, cookies, and general analytics.

How We Collect Information

We collect information when you:

- Visit our website

- Complete intake, consent, or aftercare forms
- Pay a deposit or service balance
- Contact us through a form, email, phone, text, or social media

- Subscribe to updates, if that option is offered
- Interact with our website or online services

Why We Collect Information

We collect information to:

- Schedule and manage appointments
- Provide electrolysis consultation and treatment planning
- Review relevant health, skin, hair, and treatment history
- Communicate about appointments, forms, payments, policies, or follow-up care
- Process deposits, payments, refunds, or outstanding balances
- Maintain appropriate business and treatment records
- Improve our website, services, and client experience
- Comply with legal, tax, licensing, safety, and business obligations

We ask for health-related information only when it is relevant to safe and appropriate electrolysis care.

How Information Is Stored

Blue Sky Electrolysis is hosted on the Wix.com platform. Wix provides the online platform that allows us to operate our website, booking system, forms, and payment tools. Information submitted through the website may be stored through Wix's data storage, databases, and applications.

Payment information may be processed through Wix Payments or other approved payment providers. Payment providers are responsible for securely processing payment details according to their own security standards and policies.

Blue Sky Electrolysis may also maintain limited business records, appointment notes, and treatment-related records for internal use.

How Information Is Used and Shared

Blue Sky Electrolysis uses your information only for business, scheduling, payment, treatment planning, communication, safety, and recordkeeping purposes.

We do not sell your personal information.

We may share information only when necessary, such as with:

- Wix and website service providers
- Payment processors

- Booking or form management tools
- Professional advisors, such as an accountant, attorney, or insurance provider
- Government, legal, regulatory, or licensing authorities when required by law
- Emergency or safety-related contacts when necessary to protect health or safety

We do not share sensitive client information for advertising or marketing purposes.

Health and Treatment Information

Blue Sky Electrolysis is an electrolysis business, not a medical clinic. Information submitted through intake or consent forms may include health-related details relevant to electrolysis safety and treatment planning.

We treat this information as private and use it only to support appropriate care, appointment planning, documentation, and safety. Clients should not submit information they do not want stored through online systems unless it is necessary for treatment planning. If you prefer to discuss a sensitive detail privately during your consultation, you may indicate that on your form.

Communication

Blue Sky Electrolysis may contact you by email, phone, text message, or website notifications for purposes such as:
